Debaters, remember to keep track of your own prep time.

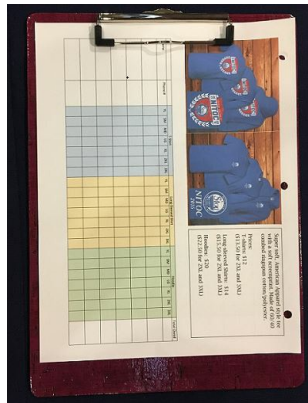

## Drury Cafeteria Q & A

1. What are the prices for the meal plans at the door? **Lunch is \$8 and dinner is \$9 at the door. Actual meal plans cannot be purchased at this point.**



2. Are the meals interchangeable? For example, can a 12 meal Plan be 5 lunches and 7 dinners? **Yes... all tickets are the same, so they are interchangeable for all meals on all days.**

3. Are people able to buy the free refill cups if they didn't buy a meal plan? **Yes! They are \$9.99 and can only be purchased in the CX (Campus Xchange) that is located inside of Springfield Hall. This is also**

the only location for cup refills. They are not supposed to be refilled in the dining hall.

4. Are each of the meal tickets for a specific day? **They are not. They are interchangeable for any meal on any day.**
